Pick-up will take place from 8:00 a.m. to 8:30 a.m. at the meeting place located at Calle Numancia, No. 47. (Quiksilver Surf School)

All children must report to the attendance control technician every morning. It is not indicated that they can come alone.

Clothing must be sporty. They must bring a beach towel, swimsuit, a change of clothes, a sun hat and sunscreen. (It is recommended to come with the Campus t-shirt)

Sports shoes must be worn for activities on the courts and sandals for going to the beach.

Knowing how to swim is a mandatory requirement for surfing and bodyboarding activities.

Pick-up of children will be between 2:00 p.m. and 2:30 p.m. We ask for punctuality.

Parents must be reachable at all times for any emergency.

It is important to inform the technicians if the child suffers from any illness, as well as other aspects that may be relevant.

The use of mobile phones and electronic games is not allowed.

They authorize the campus technicians to carry out the pertinent actions in case of emergency, accident or illness. Undertaking to inform the parents or guardians of what happened as soon as possible.
